If the Application is approved by AWB, AWB will issue the Applicant a Letter of Offer and Production Advance Offer – Addendum 2018/19 (or if the Applicant has already returned a signed Production Advance Offer – Addendum 2018/19 to AWB, only a Letter of Offer) to be accepted by the Applicant (**Production Advance Offer**). If the Production Advance Offer is accepted by the Applicant, this Application will form part of the terms and conditions of the contract between AWB and the Applicant in respect of the Production Advance.
3. The information provided by the Applicant in this Application is true and correct in every particular. AWB will be relying on the representations by the Applicant in the Production Advance Application Form and this Application in considering to offer the Production Advance to the Applicant.
4. If the Applicant is a company, a person acting in its capacity as trustee of a trust or a partnership, the persons signing this Application (jointly and severally) declare that:
  - 4.1. they have full authority and power to make this Application and make the representations in this Application in respect of the Applicant under the constitution of the company, trust instrument and partnership deed (respectively); and
  - 4.2. it is in the Applicant’s best interests, in the best interests of all beneficiaries of the trust and all partners of the partnership (respectively) to obtain the Production Advance.
5. The Applicant has not committed an act of bankruptcy, the Applicant is not insolvent and has not entered into any arrangement, composition or assignment for the benefit of creditors.

The Applicant must pay to AWB any part of the Production Advance not used for the purposes of producing such grain.

The Applicant will at its own cost, on or before 30 October 2018 effect and thereafter maintain crop insurance with a reputable insurance company licensed to conduct insurance business in Australia in respect of all crops the subject of grain contracted to AWB. The Applicant will maintain this crop insurance until all grain contracted to AWB is delivered to AWB. You will, whenever requested by AWB, make available for inspection and provide to AWB, evidence of the policy or policies of insurance or such other insurance related information required by AWB.
